THE SPRINGPOLE EFFECT: NEW JOBS AND INCREASED PROSPERITY FOR THE REGION

If approved, Springpole will directly and indirectly increase economic activity in the region by an average of \$407M per year over approximately 20 years from construction through active closure.

We value Indigenous lands and our relationships with the communities. First Mining Gold wants to contribute in meaningful ways to support the social, cultural and economic makeup of the region. The Springpole Gold Project has the potential to create new jobs and increase wealth in both its construction and operation phases.

During construction:

The creation of **2,440 full-time** equivalent positions annually through direct and indirect employment. Types of positions during construction include, camp support staff, construction labourer, equipment operator, and supervision/management.

During operation:

\$218M in labour income/annually over 12 years

Projections show 3,100 full-time equivalent positions annually through direct and indirect employment. Types of positions during operation include heavy equipment operators mill operators, miners, trades people, environmental technicians, engineers, and geologists.

New mining operations also create opportunities for new workers to enter the industry through training and apprenticeship programs that directly target local communities. FULL-TIME EQUIVALENT POSITIONS

The Project will create a total of 44,820 person-years (PYs) of employment (including direct, indirect, and induced effects) during construction, operation, and active closure.

During the approximately 20 years from construction through active closure, the Project will directly and indirectly increase economic activity, as measured in terms of Gross Domestic Product (GDP), by \$8.1 billion in revenues (undiscounted) for Ontario.

First Mining Gold is privileged to work on both Treaty 3 & 9 lands, the traditional territory of Ojibway/Chippewa in the Kenora district of northwestern Ontario. As a modern mining company, we are committed to operating responsibly and working closely with local Indigenous communities near our project site.

Our dedicated team on site was able to extinguish the fire safely and prevent what could have been more severe damage. For me, this event really emphasizes the importance of having safety and emergency response processes in place to handle these types of incidents. I am proud of the work our team did in handling this emergency, but I hope we don't have the opportunity to test them again any time soon.

From fire to ice, like many of the communities north of us, the winter road provides a critical path to supply of many of the goods and supplies we need at the Springpole site. I probably don't need to tell any of our readers that it has been a good winter for ice and we were happy to have established our winter road a couple of weeks early. Thanks to this longer season we were able to complete a successful resupply of the Springpole Camp.

Our work programs continue to advance the Springpole project, and I am very much looking forward to an exciting year ahead.


Caroline Pienaar – Senior District Geologist

Environmental Assessment Update - Notice of Commencement

Your feedback has helped us create a plan for the environmental assessment that addresses community priorities. On November 8, 2021, the Minister of the Environment, Conservation and Parks approved the Amended Terms of Reference (ToR) for the Springpole Gold Project with amendments. A copy of the approved ToR is available at: firstmininggold.com/projects/springpole-project, under the Environmental Assessment and Permitting tab.

FMG is working with the Ministry and the Impact Assessment Agency of Canada to conduct a coordinated EA process, including public consultation opportunities and the preparation of a single EA report to meet Federal and Provincial Requirements. Everyone is encouraged to actively participate in the planning of this undertaking by attending consultation opportunities or contacting staff directly with information, comments or questions. FMG expects to issue a draft of the EA report in the second quarter and share it for review. It will include the technical work carried out to assess potential effects and mitigation measures, as well as the projected benefits.

Since our last newsletter, environmental baseline work has continued to progress to support the Environmental Assessment Process.

- Hydrology stream flow/lake level monitoring
- Surface and Groundwater Quality monitoring
- Air Quality Monitoring
- Lake Profiling (water sampling at depth) Plankton/Fish community study
